POLIN Museum of the History of Polish Jews has welcomed more than 2.5 million visitors and garnered many prestigious awards since opening in 2013, including the 2016 European Museum of the Year, 2016 European Museum Academy Prize, and 2017 Europa Nostra Award. POLIN Museum is one of the most successful cultural initiatives in Poland today.

POLIN Museum is a public-private partnership and was initiated and co-founded by the Association of the Jewish Historical of Institute of Poland. The Association, in cooperation with American Friends of POLIN Museum, has launched an Endowment Campaign to secure the long-term sustainability, financial stability, and programmatic independence of POLIN Museum. The endowment funds will be held and invested in the United States.

Real Estate Assets




